Becker initially decided to build inhouse, but quickly discovered it lacked the necessary resources. The firm turned to Infodash for help. Because Infodash had been in development for years under parent company Acrowire, the firm benefited from the company's experience in the legal space as well as its Microsoft expertise.

PROBLEM

The firm's intranet had been running on SharePoint 2003, which had reached its end-of-life date in April of 2009 and was no longer supported by Microsoft after 2014. The functionality was limited. Security had become an issue. And servers to support the application were taking up space. The intranet site had mostly been abandoned by the firm's employees and was no longer providing value.

In addition, the firm has started offering a hoteling model to allocate workspace in their offices because staff no longer come in to work every day, so a new need to accommodate reservations had arisen.

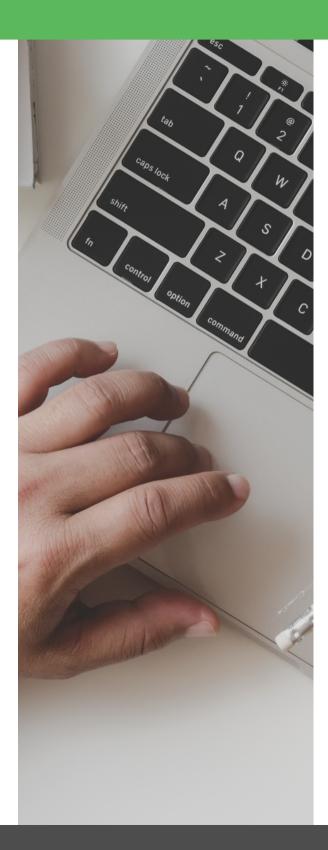
SOLUTION

Becker identified the need for a new intranet built on SharePoint Online, which would maximize its investment in Microsoft 365, eliminate the need for servers and offer easy-to-access single signon. The following functionality requirements were determined to develop an intranet that would prove valuable and functional:

- Employee directory
- Conference room reservation system by office
- Catering reservations by office
- Visitor office booking
- Employee office booking
- Pages for each office
- Pages for committees
- Pages for practice groups
- Integrated document management, financial and other systems
- Dashboards

RESULTS



Intuitive site

Becker rolled out its new intranet site while the old site was still live, so users could share feedback on what they use and need. The new intranet site is intuitive, so users required little to no training.
